 - DC/21/5470/FUL In agreement with the above comments, it is a very individual road and the original houses have very poor insulation but previous restrictions placed on residents should apply to all; the street scene needs to be preserved; I am not against refurbishment and enhancement of the properties but not that big!

To discuss the following Planning Applications: a) DC/21/5470/FUL - Alterations and Extensions to Existing Dwelling - Demolition of Existing Extensions, Garage / Workshop & Additional Building at 8 Boyton Road, Hollesley, Suffolk	 a) Councillors made the following comments: • [The Clerk advised Council that, as at 5.10pm, there were four comments on the Planning Portal: one from SCC Archaeological Services stating no further information was required, one from a resident in support and two from residents objecting] • This is a substantial 6-bed house, 2 storeys on a road with much smaller dwellings • Based solely on Character and Scale, this proposal is not in keeping with the area; we must also remember that Hollesley is within the AONB and this is outside the Village Envelope. • Previous plans for a large separate annex were rejected and these now show the annex as part of the property, which, in principle, is a good thing • This plan shows the proposed property will be virtually the full width of the plot, two storey (albeit the second storey hidden by roof ridge from the front) • The second storey will be visible from the field side • Many houses in the area have a porch but this one has a porch the full length of the house, the modern glazing is also not in keeping with the other properties • The proposed property is very large and will set a precedent for others to be extended • Conclusion: Objection on the grounds of Character and Scale being not in keeping with the location, the two storey height, the need to protect the character of the AONB and the fact that it is outside the PLB of the village (Prop: Cllr. Burbridge, Sec: Cllr. Fletcher and all in agreement) 	a) Clerk to draft reply for comment
